If CP Electronics is contacted to repair a connection that is determined to be customer equipment (example: Computer, Router or any device excluding the Internet Radio) the customer will be financially liable for the repairs and/or configuration changes made to their hardware.

Payments are due upon receipt of invoice and customer agrees to pay a late payment charge of 2% per month, 24% per annum.
